 - iv. Make a donation to cover the small item they make
- b. Returning Visitors
 - i. Updated/signed waiver
 - ii. Donation for glass used
 - iii. Projects approved before getting started
- c. Full time attendee
 - i. Make a donation to cover the cost of items they make for personal use.

6. Shop Practices

Discussion: All in concurrence with item detailed requirements

- a. Follow social distance guidelines.
- b. Adjustments for shop capacity will continue to be implemented as required
- c. Clean up after yourself. Label your work. Unless requested, do not "help" anyone with their project
- d. Safety Keep all of the exterior doors locked if there are fewer than 2 people in the shop

- f. Shop Inventory Take home anything that is yours and that you want to keep.

- e. Person who works with the customer has the lead until the project is finished
